CURRENT COVID-19 NUMBERS

With winter and flu season upon us – the College will provide the most current numbers (includes Toledo and Youngstown), noting that the numbers change frequently. As of February 20, 2022, 3 students were in COVID protocol with 1 COVID + under the direction of Karla Vitte, college health nurse.

Since March 2020, there have been 213 COVID+ students with 213 approved to return to campus.

Campus Open with Safety Precautions in Place

The College opened for in-person classes on Monday, January 10, 2022.

Enter Jefferson side of the building (grocery store type doors) with your face covering in place. Face coverings must always be worn while on campus unless alone in a private office.

Please use good hand hygiene and/or hand sanitizer. Hand sanitizer stations are on walls throughout campus and will be placed in classrooms and labs.

Anyone not following the guidelines will be subject to the Student Code of Conduct, and employees will be subject to Mercy Health HR guidelines.

If your temperature is 100 degrees or higher or you have COVID symptoms, please **do not come** to campus, and contact the college health nurse.

Nursing students follow

green circles to their destination if on Jefferson second or third floor and follow blue circles to their destination if on Madison second, third, or



STUDENT SERVICES





Empower Menu Standardization - Changed February 17, 2022

In an effort to improve the consistency and utility of the Empower Me! website, the student-facing menus were reorganized and standardized on February 17. No menu items were removed, but they may have been relocated, and some new items were added. The top-level menu headings may have undergone minor changes for naming consistency and the menu structure was flattened to reduce the number of clicks required to traverse the submenus. For example, in the current menu structure the "Change Password" option is under the "Settings and Tools" menu for prospective students but is under "Student Records" for enrolled students. In the revised structure, an "Account Settings" menu now contains the "Change Password" function.

Two-Factor Authentication Began February 1, 2022

Two-factor authentication was enabled in both the Empower Me website and the Empower client on February 1, 2022 to provide an additional layer of security beyond just a username and password. All users of Empower are impacted, including faculty, staff, students, prospective students, and alumni. You sign into Empower as usual with your username and password, and then Empower will send an email to your personal email address with a security code. You will need to enter that security code into the security validation screen in Empower to complete the sign in process. To ensure a smooth sign in experience, please take a moment to verify your personal email address in Empower in advance by using the "Update Personal Information" option in Empower Me. If you do not have a personal email address on file in Empower, it will fall back to using your Mercy College email address. Please see the online how-to guide for detailed instructions regarding the new sign-in process. The Mercy College Information Technology team is available at 419-251-9898 to help with two-factor authentication issues.

Updated Transcript Ordering Process

At the beginning of the pandemic, Mercy College of Ohio changed the transcript ordering process. We now complete all transcript requests through the National Student Clearinghouse. Most transcript requests are fulfilled within 24 hours. We encourage electronic delivery as it is the quickest method and it is free. PLEASE NOTE: We no longer accept or process paper or email transcript requests.

You can also go to the Mercy College of Ohio website (Mercycollege.edu) and search for "Transcript" this will take you to the same page. Click on the "Request a Transcript" link, then the green box titled "Order Transcripts"

Complete the next screen with your personal information. Provide your student ID number, or social security number. Answer all the required questions/prompts. (You will not be able to proceed to the next screen until all required information is provided).

On the page titled "Select Transcript and Deliver Details" under "Delivery Information" you can select Electronic Delivery or Mail/United States and there will be no charge. If you select any other delivery options, the cost will be indicated next to the method. On this page, you also have the option to upload any additional documents with your transcript.

On the Checkout page, you will sign electronically, and you will then see an order confirmation page. You will also receive a confirmation email, and if you signed up for text updates, you will receive text messages about your order.

Endowed Scholarships

The fall 2022 Endowed Scholarship application is now open. The deadline for applicants is February 28, 2022. Only one application is necessary to be considered. Use the Free Application for Federal Student Aid (FAFSA) form to apply for financial aid for undergraduate and graduate school. If you are planning on attending Mercy College between July 1, 2022 and June 30, 2023, please complete the 2022-23 Free Application for Federal Student Aid (FAFSA) now. The 2022-23 FAFSA application will be used for determining your financial aid beginning in summer 2022. You will report your 2020 tax information. Apply now at www.studentaid.gov. February will continue with entry precautions and hours of operation

All faculty, staff, and students will enter the College through the Jefferson entrance. Please park on the Jefferson side of the building. Masks will be required for all on-campus activities. If you do not have a mask or forget your mask, please ask the receptionist at the front desk who will have some extra masks. The Madison entrance remains closed for the safety and security of our students, faculty, and staff.

Student lounges and study rooms are open for both Toledo and Youngstown students. The second floor Madison building study rooms in Toledo will be closed. Please use at least three feet of social distancing.

Please follow current signage in place.

In Toledo, the hours of operation for fall semester students who wish to study on campus in study rooms or cubicles are 5am-1am Monday through Friday and the College is open from 8am-5pm on Saturday and Sunday for those who wish to study in study rooms or cubicles. Students who need to enter earlier than 8am on the weekends will be able to use their badges to access the College through the Jefferson entrance under the blue canopy.

In Youngstown, the campus is open from 6am-11pm Monday through Sunday and available via badge access during those hours.

The receptionists at the front desk in Toledo will be working 24 hours per day/seven days per week. The receptionists are staffed by Towne Park.

Bon Secours Mercy Health has provided the College with new information regarding the Covid-19 vaccine, which follows:

COVID VACCINATIONS – NEW INFORMATION

COVID VACCINATIONS – UPDATED INFORMATION as of 1/25/2022

With the recent Supreme Court decision regarding the Centers for Medicare & Medicaid Services (CMS) vaccine mandate, Mercy College's parent organization, Bon Secours Mercy Health (BSMH), has notified the College that it will be complying with the mandate and requiring the COVID vaccination. This requirement will apply to all students that either come to the Toledo Campus or Youngstown location, as well as any students who participate in any clinical activity (online student or face-to-face student). Students who are fully online AND do not have an in-person clinical component are exempt at this time.

In order to meet the final dose deadline, individuals who plan to receive the two-dose Moderna/Pfizer vaccine should receive their first dose and have their confirmation submitted no later than March 25. The second dose of these vaccines, along with confirmation documentation, will need to be completed by April 23. The Johnson & Johnson vaccine is a single dose and must be completed by the March 25th deadline. At this time, BSMH has declared that it will consider vaccine exemptions for students, based on **sincerely held religious beliefs or medical contraindication supported by documentation from a medical professional.** (Information on the exemption process can be found here, under Resources)


The following outlines the process of submitting vaccination documentation:

HOW TO SUBMIT YOUR VACCINE DOCUMENTATION

If you have received both doses, one (1) submission will be sufficient. If you have not received both doses, documentation of the first dose must be received by the March 25th deadline. If you are receiving the Johnson & Johnson vaccine, documentation must be received by the March 25th deadline.

CLINICAL STUDENTS

All clinical students will complete/upload their vaccine information to the COVID-19 component of their CastleBranch account. *Select Yes to proceed to upload your vaccination card. Students who have previously entered "No" to having had the vaccine will need to wait until the question is reset in CastleBranch before they will be able to upload the vaccine documentation.



NON-CLINICAL STUDENTS

Non-clinical students should send an email to COVIDcompliance@mercycollege.edu from the student's Mercy College email address. The email must contain the following:

Student Name

Mercy College Student ID

Major

Front and back scan or pictures of the student's vaccination card (sent as attachment to the email)

Frequently Asked Questions regarding the COVID-19 vaccine

How do I arrange to receive a COVID-19 vaccine?

Students can schedule their COVID-19 vaccine by visiting https://gettheshot.coronavirus.ohio.gov/ and using the access code: B36ZHKFQJ7 (Ohio residents) or by visiting Find a vaccine near you.

What do I do once I'm vaccinated?

Current students who have a CastleBranch account can upload their vaccination card into their CastleBranch account. Non-clinical students or students without a Castlebranch account can send an email to COVIDcompliance@mercycollege.edu from their Mercy College email address, including a scan or picture of the front and back of the vaccination card, as well the student's name, Mercy College Student ID, and major.

What if I have had COVID-19 recently?

Vaccination is still highly encouraged. If you have tested positive for COVID-19 in the past 14 days, you could wait to be vaccinated until outside of the isolation period and recovered (this is usually 10 days from symptom onset, have no fever for at least 24 hours AND improvement in other symptoms). If you have further questions, please contact the College Health Nurse, Karla Vitte.

Can I get an exemption?

Current students at the College who have a medical contraindication or a sincerely held religious belief were to submit an exemption request by January 20, 2022. COVID-19 vaccination exemption forms are located here under *Resources* and should be submitted to the following email link: exemptions.org/lege.edu
