6. Proof of Identity – Student must appear in the financial aid office and provide proof of identity

Tax Information Instructions

Both the student and the spouse are required to submit processed 2020 Federal Tax Information. The only acceptable methods to submit tax information are listed below:

IRS Data Retrieval Tool - Directly import your 2020 IRS data into your 2022-2023 FAFSA by logging into fafsa.gov and select "Make Correction".

Signed Copy of Federal Income Tax Return – Provide a SIGNED copy of your and/or your spouse's 1040 Federal Income Tax Return for 2020 and applicable schedules

IRS Tax Return Transcript - Submit your 2020 Tax Return Transcript. You can order the transcript online at irs.gov or via automated telephone request by calling 1-800-908-9946. You may also complete IRS Form 4506-T and check mark box 6a. This form is found at irs.gov. Please make sure you request an IRS Tax Return Transcript NOT the IRS Account Transcript.

<u>Verification of Non-Filing Letter</u> – If you or your spouse did not file 2020 taxes, and are not required to file taxes, then you must request a Verification of Non-Filing Letter from the IRS by submitting the IRS Form 4506-T, check marking box 7. This form is found at irs.gov. You may also attempt to order the non-filing letter online at irs.gov.

Amended Taxes – If the student or spouse filed an amended 2020 IRS tax return, please submit your original signed 2020 IRS Tax Return Transcript and a signed copy of the 2020 IRS Form 1040X that was filed with the IRS.

For your protection, please do not send personally identifiable or confidential information, including tax records and social security numbers, via email.
